- a. Registration, exhibitor, and sponsorship progress

Brian gave everyone an update, 604 attendees registered as of today, 327 exhibitors and \$107,000 in sponsorship. Hotel rooms sold out at Hershey and surrounding; only 15 rooms available –60 sessions scheduled and can have 30 more. Will have a charity raffle on Tuesday night and carnival games and will use QR codes instead of stamping the cards for bingo cards.

House passed a COLA bill and median age is 84 for this group and pretty sure this won't go anywhere. Basic Ed commission wrapped up with their final hearing and because they were so mad at each other no one asked questions and the concern is the process will go down the same rabbit hole as the budget.
